# New Schedule and System for Garbage Collection to Come into Effect from April

The frequency and days when garbage is collected will change on April 1. Calendars in Japanese explaining the changes will be distributed in March, but the major points are summarized below.

#### New Schedule -

#### 1. Burnable Garbage

Burnable garbage will be collected twice a week rather than three times a week. Collection days will either be Monday and Thursday or Tuesday and Friday, depending on your neighborhood. Be sure to check the schedule. As in the past, garbage should be put out by 8:30 a.m. to ensure collection.

Recyclable items, paper and plastic PET bottles will be collected on Wednesdays by the city. However, residents living in areas that have community collection programs (conducted by voluntary residents' groups) should continue to participate in those programs to dispose of their recyclable items. If you live in an area that does not have such a program, or if you miss the community collection day, you can dispose of the specific items of the week on Wednesdays and the city will collect them. City collections will be made even on rainy days, but the city will collect only the items specified for the week. Be sure to put the right items out for the week.

#### 2. Nonburnable Garbage

Nonburnable garbage will continue to be collected once a week on a different day in each of five areas, but in some areas,

the collection day will be changed. Check the schedule for your neighborhood. As in the past, garbage should be put out by 12:30 p.m. to ensure collection.

## **City Taxes Due Before You Leave the Country**

Individual city/prefecture resident taxes are assessed every year on individuals who have lived in Ashiya City as of January 1 and a fixed assets tax and city planning tax are imposed every year on individuals and corporations who own fixed property (land, buildings or depreciable properties) as of January 1.

If you are planning to leave the country, please contact the following to find out how to arrange for a representative to be responsible for your tax payments in your absence:

## **Light Vehicle Taxes**

People owning a light vehicle (including motorbikes) as of April 1 are subject to light vehicle tax on an annual basis. If you dispose of a vehicle or transfer ownership, or if the vehicle is stolen, you must update the registration on the vehicle to avoid being taxed. If you move out of Ashiya, you must withdraw your registration in Ashiya and then register the vehicle in your new location. You must also report the disposal of the vehicle if you plan to leave Japan.

Please bring the required documentation to the location shown below and complete procedures for changing the registration or reporting the disposal of the vehicle.

Please note that even if you dispose of your vehicle in the middle of the year you will still be responsible for paying the entire vehicle tax (there is no refund system for those who have owned a vehicle for only part of a year).

If you disagree with the figures contained in the fixed assets tax ledger, you may request a review. The request should be made in writing after April 1 (Thu.) and within 60 days of receiving your tax notice. Requests should be submitted to the Ashiya City Fixed Asset Assessment Review Board.

**Location:** Taxation Section South Conference Room, Ashiya City Office South Bldg. 1F (see map on the right)


Who can examine the records: In general, the owner of the fixed asset or his/her representative


