Let's all abide by the Citizens' Manners Ordinance

The "Ordinance to Provide for Clean, Safe and Pleasant Living Environment in Ashiya", is commonly known as Citizens' Manner Ordinance, was implemented as part of the drive to further improved living conditions in Ashiya.

Please make sure to observe each and every one of the following rules.

In public places within Ashiya

- ■Smoking is prohibited while walking, or riding a bike.

 Smoking while walking, riding a bike can cause a serious nuisance to non-smokers around you. Note that if you smoke while walking, you can harm the face/head of little children as lit cigarette in your hand is about the same height. It's dangerous, so let's stop it! Be considerate to those around you.
- ■Littering of items like cigarette butts and empty cans is prohibited.

The waste generated by careless disposal of cigarette butts and/or empty cans cannot be processed automatically. You may cause inconvenience to other people if you don't dispose of things properly at designated places.

- ■Letting dogs run loosely and improper disposal of dog feces are prohibited.
- Fireworks at night (9:00 p.m. 6:00 a.m. of the following day) is prohibited.
- Graffiti is prohibited (to the building of other people's property).

Prohibition for specific areas

- Smoking is prohibited in designated non-smoking zones contiguous to all 4 train stations in Ashiya (Hanshin Ashiya, Hanshin Uchide, JR Ashiya, Hankyu Ashiyagawa), $\S2,000$ penalty is imposed on violators.
- *****Smoking is permitted in designated smoking areas.
- Fireworks are banned daylong in fireworks-prohibited areas (Shio-Ashiya Beach zone).
- ■Barbecuing is prohibited along both sides of Ashigawa River and in the north and south banks of Canal Park.
- "Barbecuing" includes all kinds of cooking with fire. Avoid by all means using stoves or devices that release heat (electric cooking utensils, electromagnetic cookers, etc.).

Also, make sure to take all your garbage back home after a meal.

■Traffic of pleasure boats in Ashiya Canal Park is prohibited from 6:00 p.m. - 8:00 a.m. of the following day.

Let's follow these rules to make Ashiya city clean, safe and pleasant to live in.

Elevation Signs Set Up

To facilitate prompt evacuation in case of tsunami, elevation signs were set up at 30 main busy intersections in the central and south part of Ashiya. The signs show the land height at that point and are easily understandable for foreigners and visiters from outside of Ashiya.

A major earthquake is anticipated in the Nankai (southern sea) area of Japan. Let's be on the alert, and always keep in mind evacuation sites and places that are safe in case of tsunami.

Types of Taxes

■Individual City Tax/Prefecture Resident Tax

Imposed by the prefecture or city authorities where you live as of January 1 of any given year (subject to both per capita levy and per income levy); levied also on those who do not live in the city but have an office, a business establishment, or house there as of January 1 of any given year (subject only to a per capita levy).

■ Municipal Corporate Tax

Levied on corporations that have an office, a business establishment, or corporate housing in the city (tax rate based on corporate tax calculations in line with per capita levy and corporate income earned)

Fixed Assets Tax

Levied on those who own real property, such as land, housing and other types of depreciable assets (assets for business) in the city as of January 1 of any given year

■City Planning Tax

Levied on those who own real property, such as land or housing in urban areas in the city as of January 1 of any given year. City planning tax is levied together with fixed assets tax.

■Light Vehicle Tax

Levied on those settled in the city who own motorized bicycles, light motor vehicles, small-sized special motor vehicles, and two-wheeled small-sized motor vehicles as of April of any given year.

■Business Facility Tax

Levied on self-employed individuals engaged in business activities in the city (subject to asset levy if the total floor space of the business establishment in the city exceeds 1,000 square meters; subject to levy based on number of employees if the number of employees in the city exceeds 100).

Notification of Changes in Basic Residence Registration (for foreigners)

The Basic Residence Registration carries your name, date of birth, sex, address, name of head of household, relationship with the head of household, with those necessary informations are required when applying for various government services such as national health insurance, national pension, child allowance, etc. Make sure to update without delay, the registration for a change of address is required in your municipality, so as to receive government services you are entitled to.

■Busy season in the Citizens' Section

March through April is the busiest time of the year as many people move or start their jobs, and thus have to report change of address (moving in or out of Ashiya), particularly around holidays and during spring vacation.

We do our utmost effort to process your papers swiftly, but some items may require more time, so please allow enough time for your visit.

■Reporting change of address

You are required to register your new place of residence when changing address. Please note that notification of moving in Ashiya, change of address within the city, and change of household must be made within 14 days after the change.

Also, a fine may be imposed if you do not register the change of

residence within the specified time period without a legitimate reason.

In each case, refer to the table below for required documentation.

The applicant

Application can be done by oneself or head of household only. A proxy is required if others. English proxy examples are available at the URL below:

(*Note, however, that a family member who belongs to the same household within Ashiya can apply without a proxy)

Proof of identity is required when applying

To prevent falsification of items in residence registration beforehand, proof of identify is required.

The applicant must show a document that carries his/her photo for easy identification, such as a resident card (zairyu kado), a special permanent resident certificate (tokubetsu eijusha), or a

Relatives of a foreign head of household moving into his/her household must bring a document proving their relationship

In case the relationship cannot be verified, it will be recorded as enkosha (special relationship) category in resident registration. If the document proving their relationship is written in foreign language, please attach a translation with the name of the translator clearly identified.
