Notice about Subsidies for Children Attending International Schools in Ashiya City

Ashiya City provides partial subsidies for the cost of school supplies and other needs to parents/guardians living in Ashiya with children/students attending international schools (equivalent to elementary and junior high).

This guide is sent to all families of non-Japanese children/students who are enrolled in school, except Ashiya City elementary and junior high schools.

Please understand if your situation does not qualify because the school you are enrolled in is not one of the following "Eligible International Schools".

- * The eligible schools are among the Miscellaneous Schools established by School Education Law; primarily, the international schools that target non-Japanese students. Private schools are not covered.
- * If you are attending an international school other than one of the schools listed above, please inquire with the office listed in "Section 8 Inquires" to see if you are eligible or not.

Notes: If you have multiple children, please submit a separate application for each.

An application for the International School Subsidy is required each fiscal year.

2. Who is eligible to receive subsidies? (People who fulfill each of the following requirements)

- oPeople who reside in Ashiya City as of October 1st (registered in the Basic Resident Register) and are the parent/guardian of a non-Japanese child/student at a school equivalent to elementary or junior high
- oIn situations where the child/student holds multiple citizenship, including Japanese citizenship, you must receive an exemption from compulsory school attendance under School Education Law.
- The guardian's income for fiscal year 2024 must be below the eligibility criteria listed below.

Method for Calculating Income

Income amount = (Annual income - Employment income deduction, etc.) - 80,000 yen - Other deductions

If you have any income other than employment income, include those amounts as well. For business revenue, use the amount after deducting necessary expenses.

Eligible income includes gross income, retirement income, forestry income, business income from land, long-term capital gains, short-term capital gains, miscellaneous income from futures trading, treaty-qualified interest, treaty-qualified dividends, and specially qualified dividends.

A flat 80,000 yen is deducted as social insurance premium.

If you have employment or public pension income, 100,000 yen (if the total of employment and pension income is less than 100,000 yen, use that total amount) will be deducted.

Other deductions include: General disability, widow, working student deductions of 270,000 yen each; special disabled deduction of 400,000 yen; single parent deduction of 350,000 yen; actual amounts for miscellaneous loss, medical expenses, and small enterprise mutual aid premiums; and special deductions for long-term and short-term capital gains.

3. Details of Subsidies

(3) Expenses for a long school trip (1 trip per school)

*This includes trips planned for the current fiscal year.

Equivalent to enrollment in elementary school $$\pm 22,690$ per year$ Equivalent to enrollment in junior high $$\pm 60,910$ per year$

5. Deadline and Location for Submission

Deadline: October 31, 2025 (Thursday)

* Please observe the deadline.

* For paper applications, please submit the form to your current school

6. Notification of Results

Applicants will be notified of the results through the school around December.

7. Method of Payment

- (1) In general, the total annual subsidy will be deposited into the account specified on the application in December.
- (2) Because this is a subsidy for the parents/guardians, the subsidy payment cannot be transferred directly into the principal's account.
