Waste to be Disposed of in Designated Garbage Bags

Waste to Be Disposed of via **Pipeline Collection**

Pipeline facilities are installed in certain areas in the city. If you live in one of these areas, please make sure to use the pipeline facilities properly and with care.

Please use designated garbage bags when placing garbage in the pipeline.



Only burnable garbage can be placed here.

- The pipeline can collect only burnable garbage that comfortably fits in its slot (smaller than 30 cm). Do not place non-burnable garbage in the pipeline.
- Do not forcefully push the garbage into the slot, as it may cause a blockage. Please place it in the slot in multiple times.



Frequently Asked Questions about Areas with Pipeline Facilities

Q. Do I have to use designated garbage bags to dispose of garbage via the pipeline?




- Q. I don't think anyone can see if designated garbage bags are not used for the pipeline. Do I still need to use them?
- A. It's not because they can be seen, but to encourage waste sorting. Please ensure that designated garbage bags are used. We will regularly check to make sure the correct bags are being used.
- Q. Until when is the pipeline available for use?
- A. The ordinance states that the usage limit for the pipeline facilities in the Ashiyahama area is 2038, and in the Minami-Ashiyahama area, it is 2050. These facilities might be abolished sooner if their deterioration accelerates due to improper waste sorting or other factors. Please follow the rules and use the designated garbage bags to continue using the pipeline.

Plant-Based Waste

Plant-based waste often causes blockages of the pipeline. Please dispose of it properly.

Small amounts of leaves and plant debris from daily cleaning of doorsteps -> and gardens



- Remove the soil well.
- Small branches (max. 2 cm in diameter, 20 cm in length)
- Place the waste in a designated garbage bag which fits in the slot. (Do not bend branches, etc.)
- Please place the waste in the slot gradually, taking your time or disposing of it over multiple days, using designated garbage bags.

Plant-based waste generated from routine household cleaning



- Less than 50 cm in length, 10cm in diameter
- Trees and branches must be cut to a maximum length of 50 cm and diameter of 10 cm. Tie them together with a string in a bundle that can be carried with one hand and place them at the collection point. No bag needed if the bundle is tied.
- Trees and leaves that are not tied in a bundle must be placed in designated garbage bags.

Large amount of green waste

- Less than 50 cm in length, 10 cm in diameter
- Trees and branches must be cut to a maximum length of 50 cm and diameter of 10 cm. Tie them together with a string in a bundle that can be carried with one hand and place them at the collection point. No bag needed if the bundle is tied.
- They must be tied in a bundle, and collection fees apply.

How to Dispose of Waste on Other Burnable Garbage Collection Days

Waste that can be collected on other burnable garbage collection days is only burnable garbage that is less than 50 cm in length and cannot fit in a pipeline slot. Please ensure that the waste is placed in designated garbage bags.



Burnable garbage that cannot fit in a slot will be collected as other burnable garbage by garbage trucks.

- Textiles, plastics, and plant-based waste often cause blockages. Please dispose of them on other burnable garbage collection days whenever possible.
- Please place kitchen waste in the pipeline.

Other Burnable Garbage Collection Day

Once a month The 2nd Thursday

Please place the waste in the pipeline by 8:30 a.m.

Apply to arrange a bulky garbage collection for burnable garbage with the longest side of 50 cm or more.

Do not mix burnable and non-burnable garbage.



Non-burnable garbage must not be placed either in the pipeline or at the collection point along with other burnable garbage



Dispose of items with a side of 50 cm or more as bulky garbage.



Dispose of a large amount of plant-based garbage as green waste.

Please place burnable and non-burnable garbage separately within the collection point.









Place burnable garbage bags and non-burnable garbage bags separately.



Do not mix burnable and non-burnable garbage at the collection point.
