How Last Year's Municipal Budget Was Allocated

FY1999 General and Special Accounts Balance Sheet Summary

The estimated FY1999 balance sheet has been compiled. The following information applies primarily to the general account. **Inquiries:** Finance Section (Tel: 38-2011)

To achieve the restoration of our community as quickly as possible and to create a city that is comfortable, safe, and highly resistant to disasters, high priority was given in FY1999 to earthquake restoration projects such as in land readjustment, road work, and the Wakamiya area restoration and development of residential environment project. We also launched an air pollution prevention green area construction project (comprehensive park improvement project) and rebuilt Yamate Elementary School.

Due to the effects of earthquake-related projects, the municipal bond (debt) balance in the general account has broken the \$100 billion mark and has reached nearly four times its preearthquake levels. This, combined with the fact that city tax revenues have fallen from the previous fiscal year for two consecutive years due to tax reductions and the ongoing recession, has meant the continuation of this tight financial environment.

Thus, in addition to working to reduce and streamline expenses based on the Ashiya 2-Year Plan for Administrative Reform, we have made plans to secure funds for implementing projects by obtaining national and prefectural financial aid, dipping into reserve funds, and issuing municipal bonds.

Settlement Details

Settlement amounts in the general account indicate annual revenues of \$56,354,287,000 and annual expenditures of \$54,124,684,000. Revenues fell by \$6.539 million (0.0%) from last year, and expenditures fell by \$554.183 million (1.0%). The balance after subtracting expenditures from revenues is a positive \$2,229,603,000.

However, because these figures include \$1,425,864,000 which must be allotted to projects that will carry over into FY2000, the real balance after subtracting that amount is only \$803,739,000.

Graph 1 shows the trends in annual revenues and expenditures for the past six years.

Revenues

The largest portion of revenues is accounted for by tax revenues collected from the city's residents, such as the Resident Tax and Fixed Assets Tax, which total $\frac{222,523,582,000}{222,523,582,000}$. Due to reduced revenue from the individual Resident Tax caused by tax reductions and the ongoing recession, this figure dropped by $\frac{2795,667,000}{3.4\%}$ from last year. Other major sources of income include national government allotments and municipal bonds. A breakdown of sources is shown in Graph 2.

Expenditures

Graph 3 shows city expenditures by category. Civil engineering costs, which include reconstruction-related expenses, account for the largest portion of expenditures at 39.3%, while social service costs, which include welfare expenses, account for 16.1% of expenses, and public bond costs, the costs incurred for loan repayment, account for 13.0%. Efforts are being made to implement administrative reforms so as to facilitate the effective use of limited funds, and to try to revive "Ashiya: The Residential City of International Culture."

Explanation of Index Values

Ratio of current expenses to current income: 97.6%

This value indicates the ratio of current expenses such as personnel costs and financial aid costs which are determined and paid out every year, to the fixed revenues that come in every year, such as city taxes. It is said that the ideal is 70 to 80%. In Ashiya, the ratio was raised from 91.4% in FY1998. **Bond issue limit ratio:** 14.8%

This is the ratio of the amount needed to repay the principal and interest on municipal bonds (debt) to the total amount of general financial resources. If this ratio exceeds 20%, municipal bond

permits are partially restricted. The FY1998 ratio was 13.4%. **Current balance of local loans:** ¥104.2 billion

This is the amount that the city has borrowed from the national government or banks to secure funds needed for construction and other projects. It has increased with increasing issuance of municipal bonds and has reached nearly four times pre-earthquake levels.


Current reserve balance: ¥16.2 billion

Funds saved not only to ensure the availability of resources in the future, but also to allow for efficient financial management. The balance has greatly decreased since FY1993 when it reached 22.0 billion.

Amounts spent per capita: ¥651,336


Graph 1. Trends in Annual Revenues and Expenditures (unit: ¥1 million)




Graph 2. Breakdown of Annual Revenues

Long-term Nursing Care Insurance Premium Payments for Those 65 Years of Age or Older Started as of October

Although the Long-term Nursing Care Insurance System began as of April of this year, collection of the insurance premiums for those who are 65 years of age or older has begun as of October. The notification/invoice was sent in early October.

National Pension Q & A

Q: I am a foreign resident operating my own business here in Japan. When I retire, I plan to return to my home country. Since I do not plan to receive a pension from Japan, would it be all right if I did not enroll in the National Pension Plan?

A: Everyone between the ages of 20 and 59 years of age with an address in Japan must enroll in the National Pension Plan, regardless of nationality. The purpose of the National Pension Plan is not only to provide financial security in old age, but also to provide disability benefits in the event of an accident or sudden illness and bereaved family benefits as well. If you are not enrolled in the National Pension Plan, you will not be eligible for these benefits. Everyone should understand the objectives of the program, enroll in the plan and pay the pension premiums.

Those who pay the premiums for 25 years or longer can receive the pension from 65 years of age even if they are not living in Japan at that time. In addition, you will be eligible to receive a Lump-sum Payment if you withdraw from the program because you return to your home country, with the amount determined according to the length of your payment, if you paid the premiums for at least six months.

Tax Q & A

Q: I plan to return to my home country very soon. What should I do about my Resident Tax?

A: Resident Tax (City and Prefectural Resident Tax) is levied on those who are living in Ashiya City as of January 1 of that particular year. Even if you return to your home country in the middle of


the year, you are responsible for paying the entire Resident Tax for that particular fiscal year. If your employer usually makes a deduction for the Resident Tax from your monthly salary (special collection), then you must either have the remaining tax deducted in one lump sum from the last salary you receive in Japan, or you must designate someone as a representative to take care of this in your absence, submit the proper notification to the City Office and have the representative pay the tax on your behalf after you return to your country. If you pay your Resident Tax in four installments throughout the year (personal liability method), then you must either pay the remaining tax with your invoice or designate someone in the same way as for special collection, before you depart from Japan.
