# The National Health Insurance and Senior Citizen Welfare system has changed

As the population ages and birthrate declines, medical expenditures continue to rise.

In response to these circumstances, there is a need to provide assurance to residents of Japan by strengthening the insurance and pension system and making it sustainable. Adequate reform of the system has been under study, and in June, 2006 revisions were passed by the Diet. The new system is effective as of October 1st, 2006 through spring 2008. There are five major changes:

1. The percentage of medical fees that must be paid by persons 70 years old or older who receive some income has changed.

2. The percentage of fees for hospitalization that must be paid by persons 70 years old or older has changed.

3. Maternity leave has been raised to 350,000 yen.

4. Maximum benefits for dialysis have partially changed.

5. Maximum benefits for high-cost health care have changed.

Applying for high-cost health care benefits If expenses paid during one calendar month exceed the amount to be paid by individuals with national health insurance, they may apply and, if approved, receive a refund for the fees paid in excess.

Fees for meals, for beds incurring an extra charge, and for treatment not covered by insurance are not included.

Fees are refunded if paid at the same medical institution during one calendar month in excess of the amount to be paid by one individual; also, in cases where multiple payments of more than ¥21,000 were made by members of the same household who have national health insurance during the same calendar month, if the total exceeds the amount to be paid by individuals they will receive a refund for the amount overpaid.

Eligible individuals will be informed at the beginning of the month 3-4 months after going to the hospital for consultation. Apply as indicated, and money will be refunded at the hospital that performed the treatment. Receipts are needed (please save them).

Since the amount that must be paid by the individual varies according to income, tax returns must be filed (at the Taxation Section of City Hall) to determine this amount. Persons who receive no income can easily file at the National Health Insurance Desk. People with Senior Citizens' Health Insurance may receive additional benefits for high-cost health care. This is calculated separately from National Health Insurance.

Individuals with Senior Citizens' Health Insurance should apply in the same way for refunds on medical fees paid during one calendar month in excess of the amount an individual is required to pay.

Eligible individuals will be informed at the beginning of the month 3-4 months after going to the hospital for consultation. Apply as indicated.

Receipts are not needed. After applying once, no further application is needed.

# Emergency Medical System

For medical emergencies, dial 119 to call an ambulance. As a rule, Ashiya Municipal Hospital and Minami Ashiyahama Hospital accept emergency cases every day. For emergencies at night or on holidays, Ashiya Municipal Hospital handles only internal medicine cases.

Please note that pediatric emergency cases are handled on a rotating schedule at hospitals in the Hanshin region.

#### Bringing Garbage to the Refuse Disposal Center

Dec. 29 (Fri.) and 30 (Sat.) from 9:00 to 11:30 a.m. and 1:00 to 4:30 p.m.; Dec. 31 (Sun.) by noon.

Regular schedule in the new year will start on Jan. 4 (Thu.) at 9:00 a.m. \*Waiting time can be long in the year-end season, so make sure to bring garbage by Dec. 28 (Thu.).

#### Pipeline Collection in Ashiyahama and Minami-ashiyahama

Year-end collection is until Dec. 31 (Sun.) by noon, and from Jan. 4 (Thu.) in the new year.

Because burnable garbage volumes are larger than usual during this time of the year, you may not be able to dispose of garbage for extended periods of time.

Since extremely high volumes are expected on Dec. 31 (Sun.), try to dispose of garbage by Dec. 30 (Sat.) to avoid congesting the system. **Inquiries:** Refuse Disposal Center Facilities Subsection, Tel. 32-5391 Fax. 32-6247

#### Submission of Salary Payment Reports for Business Owners

Please submit Salary Payment Reports for those employed as of Jan. 1, 2007, no later than Jan. 31 (Wed.) to the municipal office of the recipients' residence (as of Jan. 1).

Salary Payment Reports must also be submitted for full or part-time workers who were paid at any time during 2006 and who retired. Submit reports to the municipal office of the worker's address at the time of retirement.

However, there is no need to do so if the total amount of wages paid to the individual on the year of retirement is 300 thousand yen or less. For inquiries call the Taxation Section, Resident Tax Subsection at Tel. 38-2016.
